

**MINUTES OF THE REGULAR MEETING OF THE MAYOR

The Regular Meeting of the Mayor and Board of Aldermen of the Town of Wesson, Mississippi, was held at 6:00 o'clock P.M., on Tuesday, March 6, 2018 in the Wesson City Hall. The following were present:

Mayor Shaw called the meeting to order. Alderman Ellison opened the meeting with a prayer. The first item of business was to approve the agenda for the meeting. Alderman Hall moved to approve the March 6, 2018 agenda. Alderman J. Ashley seconded the motion. The vote was unanimous.

The minutes of the February 6, 2018 regular meeting were set in to motion by Alderman J. Ashley. Alderman Hall seconded the motion. The vote was unanimous.

Mayor Shaw presented the March Claims for approval. After discussion of the claims, Alderman Ellison moved the claims be approved. Alderman Hall seconded the motion. The vote was unanimous.

Pamela Magee from Families First informed the board about the opening of the Family First facility within the county.

Mayor Shaw presented the board with the training schedule for Angela Hester certification classes spring conference in Flowood, MS. Alderman Hall made a motion to approve certification classes Angela. Alderman S. Ashley seconded the motion. The vote was unanimous.

Mayor Shaw requested the board to dissolve the debt of Josie Cranefield with and outstanding court fine of \$764.55 and Dwight James with an outstanding fine of \$5824.00 due to death of persons. Alderman J. Ashley made the motion to dissolve the deceased debt. Alderman Ellison seconded the motion. The vote was unanimous.

Mayor Shaw discussed the county paving of the City side of Sylvarena Road. Terry Channel has proposed the project will start sometime around July of 2018.

Alderman S. Ashley recused himself from the board meeting currently at this time. Mayor Shaw requested the board to close a portion of 10th street that is between Cotton and Wool street. The portion of the street has never been opened to the public and has been considered abandoned. Stephen Ashley and Cecelia Allen whom the landowners of the section of 10th street, have no objection to the closing of the street in question. Alderman Ellison made a motion to close a section of 10th street between Cotton and Wool street. Alderman Hall seconded the motion. The vote was unanimous.

The Grant committee proposed to use CMPDD along with Joseph Orr for the engineering on the reconstruction project of the library. Alderman King made a motion to use CMPDD for writing Grant procedures and Joseph Orr for the engineer over the library project. Alderman J. Ashley seconded the motion. The vote was unanimous.

There being no further business currently at hand, Alderman Hall moved to adjourn the meeting of the Mayor and Board of Alderman until Tuesday, April 3, 2017 at 6:00 p.m. at City Hall. Alderman J. Ashley seconded the motion. The vote was unanimous.
